### HOLD HARMLESS AGREEMENT

In consideration of being issued a permit for the use of public sidewalk for a sidewalk café, the undersigned Applicant agrees to hold harmless the Town of Valdese for any loss or damage arising out of the use of the sidewalk café or the discontinuance of any such use.

The undersigned Applicant understands and agrees that the use of the public sidewalk to operate a sidewalk café is temporary, on a day to day basis; that the Applicant does not acquire any right, title or interest in such space; that the Applicant may be required by the Town of Valdese at any time to vacate all or any part of the public sidewalk space the Applicant has been given permission to use; that upon demand to vacate such space, the undersigned Applicant agrees to promptly remove any personal property placed thereon by the Applicant and to return the space to the same condition it was in prior to the commencement of the use of the public sidewalk as a sidewalk café or to reimburse the Town of Valdese for the cost of removing such property and restoring the space to its prior condition; and that the Applicant has no recourse against the Town or its officers, employees or agents for loss or damage resulting from the Applicant being required to vacate all or any part of the sidewalk the Applicant has been granted permission to use.

The undersigned Applicant is familiar with the Town of Valdese sidewalk café ordinance and agrees to comply with that ordinance and all other applicable ordinances, statutes and regulations.
